**INTISARI**

**Latar Belakang** : Puskesmas Sedayu II Kabupaten Bantul dalam keamanan dan kerahasiaan masih belum terjaga dengan baik. Tidak adanya kunci di pintu ruangan penyimpanan rekam medis, juga belum terdapat *vaccum cleaner* sehingga berkas rekam medis masih ada yang berdebu dan juga terancam oleh hama tikus. Oleh sebab itu penulis ingin mengetahui gambaran tentang aspek keamanan rekam medis dari faktor internal dan eksternal di Puskesmas Sedayu II Kabupaten Bantul.

**Tujuan Penelitian** : Menjelaskan tentang keamanan dan kerahasiaan rekam medis di ruang penyimpanan rekam medis (*filing*) di Puskesmas Sedayu II Kabupaten Bantul.

**Metode Penelitian** : Rancangan *cross sectional*. Jenis Penelitian yang digunakan adalah deskriptif dengan pendekatan kualitatif. Metode pengumpulan data yaitu dengan wawancara dan observasi.

**Hasil Penelitian** : Berdasarkan pengamatan terhadap keamanan pengolahan rekam medis di Puskesmas Sedayu II dapat diketahui dari segi Internal masih belum aman dari bahaya kebakaran, debu dan keamanan pintu ruang penyimpanan rekam medis tidak terkunci. Dari segi eksternal perlu adanya kebijakan atau regulasi dari pemerintah tentang menjaga keamanan dan kerahasiaan rekam medis. Untuk menjaga keamanan dan kerahasiaan rekam medis diperlukan sarana prasarana serta ruangan yang cukup aman dan baik untuk menjaga kerahasiaan rekam medis.

**ABSTRACT**

**Background:** Sedayu II Health center, Bantul Regency in security and confidentiality is still not well maintained. There is no key in the door of the medical record storage room, there is also no vacuum cleaner so that the medical record file is still dusty and also threatened by rat pests. Therefore the author wants to know the description of the safety aspects of the medical record from internal and external factors at the Sedayu II Health Center, Bantul Regency.

**Objectives:** Explain the security and confidentiality of medical records in the medical record storage room (*filing*) at Sedayu II Health center, Bantul Regency.

**Research Method:** Cross sectional design. The type of research used is descriptive with a qualitative approach. The method of data collection is by interview and observation.

**Results:** Based on observations on the safety of medical record processing at the Sedayu II Health Center, it can be seen that the Internal Safety is still not safe from the dangers of fire, dust and the security of the door of the medical record storage room. Externally, there needs to be a policy or regulation from the government about maintaining the security and confidentiality of medical records. To maintain the security and confidentiality of medical records, it is necessary to provide adequate and safe facilities for infrastructure and rooms to maintain the confidentiality of medical records.
