

**TINJAUAN KEAMANAN DAN KERAHASIAAN REKAM MEDIS
DENGAN METODE *LITERATURE REVIEW*

INTISARI

Latar Belakang: Rumah sakit adalah institusi pelayanan kesehatan yang menyelenggarakan pelayanan kesehatan secara perorangan dan paripurna yang menyediakan pelayanan rawat inap, rawat jalan dan gawat darurat. Keamanan dokumen rekam medis menyangkut dalam bahaya dan kerusakan dokumen rekam medis sendiri dan kerahasiaan merupakan pembatasan pengungkapan informasi pribadi. Dokumen rekam medis bersifat rahasia maka pimpinan Fasyankes wajib menjaga keamanan dan kerahasiaan rekam medis, baik keamanan fisik maupun isi rekam medis.

Tujuan Penelitian: Mengetahui keamanan dan kerahasiaan rekam medis dari berbagai jurnal.

Metode Penelitian: Metode dokumentasi dengan cara pengumpulan data berupa jurnal yang telah dipublikasi melalui *google scholar*.

Hasil Penelitian: Berdasarkan *review* dari 3 jurnal letak ruang *filing* yang kurang strategis sehingga masih banyak petugas lain yang berlalu lalang yang mengakibatkan kurangnya jaminan kerahasiaan rekam medis dan juga masih ada dokumen rekam medis yang dibawa oleh pasien sehingga banyak yang hilang. Selain itu, map rekam medis belum sesuai standar sehingga mudah rusak dan juga belum adanya fasilitas yang memadai.

Kesimpulan: Pada hasil penelitian secara umum rekam medis belum aman dan masih kurangnya jaminan kerahasiaan rekam medis.

**SECURITY AND CONFIDENTIALITY REVIEW OF MEDICAL RECORDS

ABSTRACT

Background: Hospital is a health service institution that provides individual and complete health services that provide inpatient, outpatient and emergency services. The security of medical record documents concerns the danger and damage to the medical record documents themselves and confidentiality is a limitation of the disclosure of personal information. The medical record document is confidential, so the leadership of the health facility is obliged to maintain the security and confidentiality of the medical record, both physical security and the contents of the medical record.

Objectives: To determine the safety and confidentiality of medical records from various journals.

Methods: The method of documentation is by collecting data in the form of journals that have been published through google scholar.

Results: Based on a review of 3 journals, the location of the filing room was not strategic enough so that there were still many other officers passing by which resulted in a lack of assurance of the confidentiality of medical records and also medical record documents brought by patients so that many were lost. In addition, the medical record folder is not up to standard so it is easily damaged and there are no adequate facilities.

Conclusion: In general, medical records are not safe and the confidentiality of medical records is still lacking.
