

**ANALISIS BERKAS RINGKASAN PULANG (*DISCHARGE SUMMARY*)  
PASIEN RAWAT INAP DI RUMAH SAKIT DKT DR. SOETARTO  
TK.III YOGYAKARTA TRIWULAN I TAHUN 2018**

**INTISARI**

**Latar Belakang :** Menurut Keputusan Menteri Kesehatan No. 129 Tahun 2008 tentang Standar Pelayanan Minimal Rumah Sakit, kelengkapan pengisian rekam medis adalah lengkapnya pada pengisian rekam medis khususnya pada lembar resume medis dalam waktu 24 jam setelah selesai pelayanan dengan standar pengisian 100%. Ringkasan pulang (*discharge summary*) adalah ringkasan pelayanan yang diberikan oleh tenaga kesehatan khususnya dokter, selama masa perawatan hingga pasien keluar setelah pelayanan dan dikembalikan ke Unit Kerja Rekam Medis (UKRM).

**Tujuan Penelitian :** Mengetahui tingkat kelengkapan pengisian ringkasan pulang (*discharge summary*).

**Metode Penelitian :** Rancangan penelitian ini menggunakan metode deskriptif dengan metode kuantitatif, dengan pendekatan retrospektif, teknik pengambilan sampling yang digunakan adalah nonprobability sampling dengan jenis purposive sampling. Jumlah sampel yang digunakan sebanyak 80 rekam medis pasien rawat inap triwulan pertama di Rumah Sakit Dkt Dr. Soetarto Tk.III Yogyakarta

**Hasil Penelitian :** Hasil penelitian menunjukkan bahwa kelengkapan ringkasan pulang (*discharge summary*) berdasarkan review identifikasi sebesar 67,49%, berdasarkan pelaporan penting sebesar 60%, berdasarkan autentifikasi sebesar 55%, berdasarkan pendokumentasian yang benar sebesar 100%

**Kesimpulan :** Analisis kelengkapan berkas ringkasan pulang (*discharge summary*) di rumah sakit DKT Dr. Soetarto Tk.III Yogyakarta termasuk kategori kurang, Karena masih banyak ringkasan pulang (*discharge summary*) yang tidak lengkap.

# **ANALYSYS DISCHARGE SUMMARY FILE OF PATIENT IN DKT DR.SOETARTI TK III YOGYAKARTA HOSPITAL QUARTER I OF 2018**

## **ABSTARCT**

**Background:** According to Minister of Health Decree No. 129 of 2008 concerning Hospital Minimum Service Standards, the completeness of filling in medical records is complete in filling out medical records especially on medical resume sheets within 24 hours after completion of service with a 100% filling standard. A discharge summary is a summary of services provided by health personnel, especially doctors, during the treatment period until the patient leaves after service and is returned to the Medical Record Work Unit (UKRM).

**Objectives:** To find out the completeness of completing the discharge summary.

**Method:** The design of this study uses descriptive method with quantitative methods, with a retrospective approach, the sampling technique used is nonprobability with the type of purposive sampling. There were 80 inpatient medical records quarter I at DKT Dr. Soetarti TK III Yogyakarta Hospital.

**Result:** The result shows that completeness of discharge summary based on identification review as many as 64,49%, based on important reposts as many as 60%, based on authentication as many as 55% and based on correct documentation is 100%.

**Conclusion:** Completeness analysis of discharge summary file at DKT hospital Dr. Soetarto Tk. III Yogyakarta is in the poor category, because there are still many incomplete summaries.
