**INTISARI**

**Latar Belakang:** Di Instalasi Rekam Medis RSJ Yogyakarta, untuk menjaga kerahasiaan rekam medis adalah tempat harus aman, tidak semua orang boleh akses ke ruangan, di samping pintu masuk ruang *filing* terdapat *finger print*. Di RSJ Grhasia Yogyakarta untuk rak belum mencukupi jadi untuk berkas rekam medis masih banyak yang di luar rak dan tidak tertata rapi menyebabkan map berkas rekam medis masih banyak yang rusak. Hal ini beresiko berkas rekam medis dapat di akses oleh pihak yang tidak berwenang.

**Tujuan Penelitian:** Mengetahui elemen penilaian SNARS atau MIRM 14, mengetahui upaya di rumah sakit untuk menjaga kerahasiaan rekam medis, mengetahui persiapan standar MIRM 14 SNARS versi 2017.

**Metode Penelitian:** Jenis penelitian yang digunakan adalah deskriptif dengan pendekatan kualitatif. Rancangan penelitian yang digunakan adalah rancangan *cross sectional* (potong lintang).

**Hasil:** Terdapat 3 elemen penilaian MIRM 14. Upaya menjaga kerahasiaan rekam medis pada ruang *filing* aktif sudah terdapat *finger print*. Persiapan standar MIRM 14 ada 3 elemen penilain.

**Kesimpulan:** Elemen penilaian MIRM 14 di RSJ Grhasia Yogyakarta sudah dilaksanakan kecuali yang elemen penilaian 3 kepatuhan terhadap di monitor belum terlaksanakan.

**ABSTRACT**

**Background:** *In the Medical Records Installation at Yogyakarta Hospital, to maintain the confidentiality of medical records is a place to be safe, not everyone can access the room, beside the entrance the filing room has finger print. In Grhasia Yogyakarta Hospital, there is not enough shelves for the shelves, so there are still many medical record files that are out of the shelves and are not neatly arranged causing many medical record file folders to be damaged. This risks the medical record file can be accessed by unauthorized parties.*

**Objective:** *To find out the elements of SNARS or MIRM 14 assessment, to find out the efforts in the hospital to maintain the confidentiality of medical records, to know the preparation of the 2017 version of the MIRM 14 SNARS standard.*

**Method:** *The type of research used is descriptive with a qualitative approach. The research design used was cross sectional design.*

**Conclusion:** *The element of MIRM 14 assessment in Yogyakarta Grhasia Hospital has been implemented except the element of assessment 3 compliance with the monitor has not been carried out*
