Latar belakang : Berdasarkan Surat Keputusan Direktur No 445/3.1/KPTS/I/2019 mengatur formulir rekam medis dan isi spesifik rekam medis formulir laporan operasi sebagai acuan dalam pembuatan formulir laporan operasi. Formulir laporan operasi berguna untuk melaporkan kondisi pasien sebelum, selama, dan setelah mendapat tindakan/ operasi.

Tujuan : Merancang *design interface* formulir laporan operasi elektronik rawat inap di RSUD Kota Yogyakarta.

Metode : Metode yang digunakan dalam penelitian ini adalah prototipe.

Hasil : Memiliki hasil *design* formulir laporan operasi elektronik yang dapat dioperasikan *diprint* berformat pdf.

Kesimpulan : Menu yang perlu ditambahkan yaitu jumlah pendarahan, Penggunaan tab untuk memindahkan krusor menu secara otomatis, Tanda tangan bisa klik simpan dan *diprint* merupakan tantangan peneliti dalam menuntaskan formulir elektronik ini.
