

TINJAUAN PELAPORAN KASUS PENYAKIT DI PUSKESMAS GAMPING I

INTISARI

Latar Belakang: Sistem Pencatatan dan Pelaporan Terpadu (SP2TP) Puskesmas merupakan rangkaian kegiatan pencatatan dan pelaporan data medis umum, fasilitas, personel, dan upaya pelayanan di Pukesmas. Laporan bulanan data kesakitan (LB1) cukup penting untuk mengatasi masalah kesehatan. jika dikerjakan secara tepat dan akurat dalam membuat laporan, data dan informasi akan sangat bernilai sebagai dasar pengambilan keputusan dan data yang di dapat pun harus dapat dipertanggungjawabkan. Berdasarkan hasil studi pendahuluan yang dilaksanakan di Puskesmas Gamping I kepada petugas Rekam Medis, menyatakan bahwa masih terdapat permasalahan terkait keterlambatan Laporan Bulanan Data Kesakitan (LB1) kepada Dinas Kesehatan Kabupaten sebesar 8,3% yang terjadi pada tahun 2021 yaitu pada bulan Desember.

Tujuan Penelitian: Untuk mengetahui tentang pelaporan kasus penyakit di Puskesmas Gamping I

Metode Penelitian: Penelitian ini menggunakan metode kualitatif menggunakan teknik *accidental sampling* dengan data primer yang diperoleh dari objek penelitian langsung menggunakan wawancara dan observasi.

Hasil: Berdasarkan hasil Penelitian, Pengumpulan (LB1) di Puskesmas Gamping I masih terdapat keterlambatan dikarenakan hanya terdapat 1 petugas dengan latarbelakang rekam medis dan masih merangkap pekerjaan serta terkadang masih terkendala koneksi internet. Keterlambatan waktu pengiriman laporan bulanan data kesakitan (LB1) pada tahun 2021 di Puskesmas Gamping I sebesar 8,3% terjadi pada bulan desember, sedangkan ketepatan waktu pengiriman telah mencapai 91,7%.

Kesimpulan: Pelaporan bulanan (LB1) masih terdapat keterlambatan sebesar 8,3%, sedangkan ketepatan waktu pengiriman telah mencapai 91,7%.

REVIEW OF DISEASE CASE REPORTING AT PUSKESMAS GAMPING I

ABSTRACT

Background: The Integrated Recording and Reporting System (SP2TP) of the Puskesmas is a series of activities for recording and reporting general medical data, facilities, personnel, and service efforts at Pukesmas. Monthly reports of morbidity data (LB1) are quite important to overcome health problems. if done correctly and accurately in making reports, data and information will be very valuable as a basis for decision making and the data obtained must also be accountable. Based on the results of a preliminary study conducted at the Puskesmas Gamping I to Medical Record officers, it was stated that there were still problems related to the delay in the Monthly Pain Data Report (LB1) to the District Health Office of 8.3% which occurred in 2021, namely in December.

Objective: To find out about reporting disease cases at the Puskesmas Gamping I

Method: This study uses a qualitative method using accidental sampling technique with primary data obtained from the object of research directly using interviews and observations.

Result: Based on the results of the study, collection (LB1) at the Puskesmas Gamping I was before the 10th of the following month but there was still a delay. The equipment that supports the implementation activities is in the form of 2 computers and 1 printer where the computer is also used as a tool to perform services, sometimes the internet connection is still constrained. The delay in sending the monthly report on morbidity data (LB1) in 2021 at the Gamping I Health Center by 8.3% occurred in December, while the timeliness of delivery has reached 91.7%.

Conclusion: Monthly reporting (LB1) there is still a delay of 8.3%, while on time delivery has reached 91.7%.
