

# TINJAUAN APLIKASI SIMPUS TERHADAP KEBUTUHAN PELAPORAN SP2TP DI PUSKESMAS DENGAN

## *LITERATUR REVIEW*

### INTISARI

**Latar Belakang** : setiap fasilitas kesehatan salah satunya puskesmas wajib melaporkan segala kegiatan yang dilakukan. Sistem Pencatatan dan Pelaporan Terpadu Puskesmas (SP2TP) merupakan kegiatan pencatatan dan pelaporan umum terkait sarana, tenaga, dan upaya pelayanan kesehatan di masyarakat, akan tetapi proses pelaksanaan pelaporan SP2TP belum sepenuhnya dilaksanakan dengan baik. Masih ada beberapa laporan puskesmas yang belum menggunakan simpus sehingga menyebabkan ketidaktepatan waktu pengumpulan laporan ke dinas kesehatan.

**Tujuan** : Mengetahui bagaimana simpus dalam menunjang kegiatan pelaporan SP2TP di Puskesmas dengan metode *Literatur Review*.

**Metode** : penelitian ini menggunakan jenis penelitian tinjauan pustaka pada jurnal ilmiah dengan tema tinjauan aplikasi simpus terhadap kebutuhan pelaporan SP2TP di Puskesmas.

**Hasil** : berdasarkan hasil tinjauan dari berbagai jurnal, penerapan simpus belum sepenuhnya mendukung pelaksanaan SP2TP, pelaporan masih focus pada pola penyakit dan 10 penyakit terbanyak, serta laporan yang disampaikan tidak lengkap dan pelaksanaan SP2TP belum optimal yang disebabkan masih kurangnya tenaga SP2TP.

**Kesimpulan** : secara keseluruhan penerapan simpus belum sepenuhnya mendukung pelaksanaan SP2TP.

# **SIMPUS APPLICATION REVIEW OF NEEDS REPORTING OF SP2TP IN PUSKESMAS WITH LITERATURE REVIEW**

## **ABSTRACT**

**Background:** every health facility one of them must report all activities carried out, the integrated Puskesmas recording and reporting system (SP2TP) is general recording and reporting activity related to health facilities, personnel and health service efforts in the community, however the SP2TP reporting process has not been fully implemented properly. There all still a number of Puskesmas report that have not used the simpus, which result in innacurate time for reporting to the health department.

**Purpose:** to fin of how Simpus is tu support SP2TP reporting activities at Puskesmas with “literature review”.

**Methods:** This study uses a type of literature review research on scientific journals with the theme simpus applicaton review of needs reporting of sp2tp in Puskesmas.

**Result:** Based on the results of reviews from several journals, application of simpus not fully supported the implementation of SP2TP, reporting still focuses on diseasepatterns and 10 most disease. The report submitted is incomplete and the implementation of SP2TP is not optimal due to the lack of SP2TP staff.

**Conclusion:** overall the application of the simpus has not fully supported the implementation of SP2TP.
