INTISARI

Latar Belakang: Formulir adalah suatu lembaran kertas yang berisikan keterangan baik yang tertulis maupun yang terekam tentang identitas pasien, anamnesa, pemeriksaan fisik, laboratorium, diagnosa, pemeriksaan fisik dan segala pelayanan tindakan medis. Formulir rekam medis harus memiliki kualitas data dan mutu yang baik guna untuk peningkatan kualitas informasi yang akurat dan baik dapat didukung adanya rancangan formulir yang baik. Rumah Sakit PKU Muhammadiyah Wonosari merupakan rumah sakit Tipe D yang dahulunya adalah sebuah balai pengobatan dan menjadi rumah sakit PKU Muhammadiyah Wonosari, namun untuk analisis desain formulir rekam medis masih belum spesifik di tinjau dari komponen formulir, item formulir dan redesain formulir rekam medis.

Tujuan Penelitian: Mengetahui komponen yang tersedia pada formulir rekam medis di tinjau dari aspek *anatomy*, isi dan fisik, mengetahui item yang tersedia pada formulir rekam medis dan redesain formulir rekam medis di rumah sakit PKU Muhammadiyah wonosari.

Metode Penelitian: jenis penelitian yang digunakan adalah kualitatif dengan pendekatan *research and development*. Metode pengumpulan data dengan cara observasi, wawancara, studi dokumentasi dan fokus grup diskusi.

Hasil Penelitian: Komponen perancangan Formulir Resume Medis, Ringkasan Masuk dan Keluar, Resume Medis dan *Informed Consent* ditinjau dari segi aspek anatomi, isi dan fisik belum tersedia dan spesifik. Item yang tersedia belum lengkap pada Formulir Resume Medis, Ringkasan Masuk dan Keluar, Resume Medis dan *Informed Consent*. Redesain ulang Formulir Resume Medis, Ringkasan Masuk dan Keluar, Resume Medis dan *Informed Consent* rumah sakit PKU Muhammadiyah wonosari.

Kesimpulan: Komponen desain Formulir rekam medis di rumah sakit PKU Muhammadiyah Wonosari ditinjau dari segi aspek masih terdapat Formulir yang belum diterapkan, Ketidaklengkapan item Formulir rekam medis di rumah sakit PKU Muhammadiyah Wonosari, belum dilakukan perancangan redesain Formulir rekam medis di rumah sakit PKU Muhammadiyah Wonosari.

The Analysis on Medical Record Form Design in PKU Muhammadiyah General Hospital of Wonosari in 2017

ABSTRACT

Background : A form is a paper sheet containing written or recorded information about a patient's identity, anamnesis, physical examination, laboratory, diagnosis, and all kinds of medical intervention service. The form of data compilation creates documentation. The form of report demands a decision or intervention orientation determination. A medical record form must have a proper data quality to enhance the quality of accurate information which can be supported by a proper form design. PKU Muhammadiyah general hospital of Wonosari is a hospital of type D which used to be a medication house. Nevertheless, the analysis on medical record form design remains unspecified according to the aspect of form component, form item, and form redesign.

Objective : To identify the available components in medical record forms from the aspect of anatomy, content, and physics. To identify the available items in medical record forms and medical record forms redesign in PKU Muhammadiyah general hospital of Wonosari.

Method : This was a qualitative study with research and development approach. The subjects in this study were doctors, nurses, medical record staff, and registration staff. The objects were medical record forms in PKU Muhammadiyah hospital of Wonosari. Data compilation methods were observation, interview, documentation study, and focused discussion group.

Result : Medical resume form design component, sign In and Out form, medical resume and informed consent from the aspect of anatomy, content, and physics, were not available and not specific. The available items were not complete in medical resume form, sign in and out form, medical resume and informed consent. Medical resume form redesign, sign in and out form, medical resume and informed consent in PKU Muhammadiyah general hospital of Wonosari.

Conclusion : Medical record form design component in PKU Muhammadiyah general hospital of Wonosari from the aspect, there were forms that were not applied yet, incompleteness of medical record form item in PKU Muhammadiyah general hospital of Wonosari, medical record form redesign was not implemented yet in PKU Muhammadiyah general hospital of Wonosari.
