

LITERATURE REVIEW : ANALISIS KELENGKAPAN PENGISIAN FORMULIR RESUME MEDIS PASIEN RAWAT INAP DI RUMAH SAKIT

INTISARI

Latar Belakang: Dalam pelaksanaannya rumah sakit dituntut untuk menyelenggarakan rekam medis dengan tujuan untuk menunjang tercapainya tertib administrasi dalam rangka upaya peningkatan pelayanan kesehatan. Untuk dapat mengolah informasi pada rekam medis pasien dibutuhkan rekam medis yang lengkap dalam pengisinya, salah satu lembar dalam rekam medis yang harus terisi lengkap adalah formulir resume medis. Namun faktanya di beberapa rumah sakit masih terdapat pengisian formulir resume medis yang belum lengkap 100%.

Tujuan: Untuk mengetahui presentase kelengkapan pengisian formulir resume medis pada pasien rawat inap di rumah sakit.

Metode: Metode penelitian *literature review*.

Hasil: Dari hasil analisis jurnal, pada jurnal Sugiyanto et al., (2015) di RSUD R.A Kartini Jepara didapati kelengkapan untuk *review identifikasi* sebesar 82%, *review laporan penting* 25%, *review autentifikasi* 54%, *review pendokumentasian* yang benar ada 35%. Penelitian terdahulu oleh Sawondari et al., (2020) di RUMKITAL Dr. Ramelan Surabaya didapati kelengkapan untuk *review identifikasi* sebesar 80%, *review laporan penting* 85%, *review autentifikasi* 85%, *review pendokumentasian* yang benar 80%. Penelitian yang telah dilakukan oleh Yuniati & Rifa'i, (2018) di Rumah Sakit Islam Gondanglegi Malang didapati kelengkapan *review identifikasi* sebesar 100%, *review laporan penting* 64%, *review autentifikasi* 89%, *review pendokumentasian* yang benar 75%. Menurut penelitian Wardana & Sugiarsi, (2017) di Rumah Sakit Umum Fitri Candra Wonogiri didapati kelengkapan *review identifikasi* sebesar 89%, *review laporan penting* 72%, *review autentifikasi* 95%, *review pendokumentasian* yang benar 69%. Penelitian terdahulu oleh Ani & Viatiningsih, (2017) di Rumah Sakit Haji Pondok Gede Jakarta didapati kelengkapan *review identifikasi* 99%, *review laporan penting* 77%, *review autentifikasi* 76%, *review pendokumentasian* yang benar 69%.

LITERATURE REVIEW : ANALYSIS COMPLETENESS OF FILLING INPATIENT MEDICAL RESUME FORM IN THE HOSPITAL

ABSTRACT

Background: In implementation, hospitals are required to carry out medical records with the aim of supporting the achievement of orderly administration in the context of efforts to improve health services. To be able process information in a patient's medical record, a complete medical record is required in filling it out, one of the sheets in the medical record that must be filled in completely is the medical resume form. But the fact is that in some hospitals there are still incomplete medical resume forms filling out 100%.

Objective: To know the percentage of completeness in filling out inpatient medical resume form at the hospital.

Method: Research method of *literature review*.

Result: From the results of the journal analysis, in the journal Sugiyanto et al., (2015) at the R.A Kartini Hospital, Jepara, it was found that 82% of complete identification reviews were available, 25% important report reviews, 54% authentication reviews, 35% correct documentation reviews. Previous research by Sawondari et al., (2020) at RUMKITAL Dr. Ramelan Surabaya found 80% completeness for identification review, 85% important report review, 85% authentication review, 80% correct documentation review. Research conducted by Yuniati & Rifa'i, (2018) at the Gondanglegi Islamic Hospital in Malang, found that the complete identification review was 100%, the review of important reports was 64%, the authentication review was 89%, the correct documentation review was 75%. According to research by Wardana & Sugiarsi, (2017) at the Fitri Candra Wonogiri General Hospital, it was found that the completeness of the identification review was 89%, the review of important reports was 72%, the authentication review was 95%, the correct documentation review was 69%. Previous research by Ani & Viatiningsih, (2017) at Pondok Gede Haji Hospital, Jakarta, found 99% complete identification review, 77% review of important reports, 76% authentication review, 69% correct documentation review.
